Please write your essay in the form of a journal editorial on the following topic:

"The effects of doping in sport are more than physical"

## **Eligible applicants:**

- *Undergraduates* (medical, physiotherapy, allied healthcare professionals) enrolled on a healthcare course at university in either England, Scotland, Wales, Northern Ireland, or the Republic of Ireland, on the closing date.
- or *recently graduated* (within 2 years e.g. foundation year 1 &2 doctors or equivalent)

#### **Award**

The successful award winner will receive:

- £100 prize
- A free one-day conference ticket (specifics to be clarified after awarded)
- Mentorship from the FSEM to support the winner to publish their editorial piece (e.g., in BASEM Today).

#### **Deadline/Submission**

Please email your submission <u>pr@fsem.ac.uk</u> before 12pm on <u>31<sup>st</sup> January 2024.</u> In the body of the email please state the following:

- Full Name
- University
- University course and year of study/date of graduation
- Undergraduate or recent graduate status
- Employer (if graduated)
- Contact details (email and mobile)

Please attach your essay in a word document or PDF format.

Please label your essay with the topic title but you must ensure that your name is not contained anywhere in your essay or filename. The competition administration team will rename the files so that marking will be anonymous.

### **Guidelines and Requirements:**

- The essay should be in the style of a journal editorial. An editorial is a piece of writing that expresses the opinion of the author on a topic of public interest. It usually aims to persuade the readers to agree with the author's viewpoint or to take some action (see https://bjsm.bmj.com/pages/authors#editorial)
- Formatting should be Times New Roman, font size 12, maximum word count 800 words (excluding title and references)
- A maximum of 3 tables, graphs, or images may be used, although they are not essential
- Quotes should be identified within " " and appropriately referenced
- No more than 8 references
- Reference format is Vancouver (number superscript)
- Keep the title short and succinct to attract the readers (max two lines Size 12 font).
- Sub-headings are recommended.
- Include total word count at the end
- All submissions will be double-marked according to the marking criteria below
- We will aim to release results as soon as possible.

### Please read the following statement on plagiarism and academic misconduct.

All content submitted to the essay competition must be your own ideas, thoughts, or judgements, and must be expressed in your own words. You must ensure that you formally recognise and reference the existing knowledge and ideas on which your work is based. The use of artificial intelligence in the preparation or generation of the content for submission to the essay competition is expressly prohibited.

By submitting your essay, you are confirming that you have read and understood the advice above regarding plagiarism and the use of artificial intelligence in your submission.
