ROLE SUMMARY

This is an exciting role working for UK Athletics on the World Class Programmes (WCP) with both Olympic and Paralympic athletes across multiple disciplines including Sprints, Jumps, and Endurance. The role will be based out of the National Performance Institute (NPI) in Loughborough and will support athletes and coaches as part of an experienced multi-disciplinary team including S&C, Biomechanics, and Physiology amongst others.

The successful candidate will work closely with the Head of Therapy and Medicine to oversee and manage therapy across the Olympic, Paralympic, and Pathway Programme, ensuring the therapy service delivers a strategic, and collaborative approach to optimise athlete availability for preparation and world-leading performance.

The successful candidate will provide world leading therapy support to athletes on the WCP at the NPI and to identified remote athletes as required. There will be a requirement to work at domestic and international camps and competitions supporting both Olympic and Paralympic athletes, in the region of 12 weeks / year.

KEY RESPONSIBILITIES

- Work collaboratively with the Head of Therapy and Medical Services to ensure the development and effective implementation of a therapy strategy that assures health optimisation for all Olympic and Paralympic athletes on the WCP.
- Take a leading role in identifying and developing ways to mitigate health risks aligning to programme goals, aspirational targets and individual athlete plans.
- Establish and maintain excellent working relationships with athletes, coaches and other support staff.
- Proactively review the therapy service provision to provide insight to drive progress and improve support.
- As a key member of the Therapy and Medicine team, work to establish a trusted and skilled network of therapists, with capacity and capability to effectively support a

- world-class track and field athlete programme.
- Work with the Medical Operations
 Manager to ensure the effective and
 efficient operations of the NPI clinic.
 Including ensuring the therapy rota
 and equipment are available to
 underpin athlete health delivery.
- Lead the Therapy team at camps and at major championships as required.
- Provide therapy support for a caseload of WCP Olympic and Paralympic athletes.
- Ensure that health care practitioners operate as an efficient, connected support team, ensuring an interdisciplinary approach across human performance and athlete health to optimise delivery.
- Work closely with the sport's medical team to quality assure practitioners and medical practice across the World Class Programme.

- Ensure that clinical and health governance standards impact all decisions and ways of working across the performance programme.
- Contribute to all aspects of athlete health planning in preparation for attendance at major competitive events (e.g., World Championships, Olympics, Paralympics).
- Provide leadership and line management to Lead Paralympic Therapist, Pathway Therapy Lead, WCP Therapy Contractors. This will include the strategic alignment of objectives and workstreams and supporting learning and development in collaboration with UKSI.
