Form 8: Senior Clinical Supervisor Structured Report

For GPs seeking accreditation as GPwER in Musculoskeletal Medicine with the Faculty of Sports and Exercise Medicine

In that case, this can act as guidance to support their ongoing training and development in preparation for resubmission (or delayed submission until performance in the relevant domains has been satisfactorily demonstrated to an acceptable level).

Level 3: Entrusted to act with indirect supervision – The applicant may provide clinical care when the supervising physician is not physically present within the hospital or other site of patient care, but is available by means of telephone and/or electronic media to provide advice, and can attend at the bedside if required to provide direct supervision
Level 4: Entrusted to act unsupervised
