Guidance related to qualifications and certification for Doctors working in non-grassroots sport in the UK

Purpose

This framework is aimed at Doctors, employers, indemnity companies and other key stakeholders involved in the provision of healthcare to athletes competing in non-grassroots sport in the United Kingdom. For the purposes of this document, non-grassroots sport is defined as involving athletes who are semi-professional, professional or part of a performance-related programme competing in national or international level competition, although individual sports organisations may effectively set where the grass roots and non-grass roots boundary is in their sport. This document provides a consensus on the minimum advised standards related to qualifications and certification to support safe practice and good governance in athlete healthcare.
